Application: Apply 2 times a day after cleansing the skin with face lotion or toner.

Information: To wash your face before applying the cream, we advise to use surfactant-free washing agents, since it is well known that surfactants deprive the skin of oil, drying it out. It is for this reason that soaps, even the liquid ones, are discouraged. Hydrophilic washing oils can be suggested as a better alternative.
